RECITALS:

- 1. Applicability of Master Covenant to Development Area. This Notice is filed with respect to all Lots located within: (i) Rough Hollow South Shore II, Phase 1, Section 1, a subdivision of record in Travis County, Texas, according to the map or plat thereof recorded under Document No. 200900051, Official Public Records of Travis County, Texas; and (ii) Rough Hollow South Shore II, Phase 1, Section 2, a subdivision of record in Travis County, Texas, according to the map or plat thereof recorded under Document No. 200900050, Official Public Records of Travis County, Texas (collectively, the "Development Area").
